ORDER u/s 144 Cr PC

Whereas it has been made to appear to me that songs are played glorifying the Vulgar, Alcoholic, Wine, Liquor, Drugs, Weaponry and violence in any song even in live shows.

Hon'ble Punjab & Haryana High Court, Chandigarh has directed in CWP No.6213 of 2016 (O & M) and CWP 27011 of 2016 that to ensure that no songs are played glorifying the Vulgar, Alcoholic, Wine, Liquor, Drugs, Weaponry and violence in any song even in live shows.

In compliance of Hon'ble Punjab and Haryana High Court, Chandigarh and order to prevent any annoyance, injury to any person and to prevent any danger to the human life and in order to check illegal activities of anti-social elements and further keeping in view the public safety I, Varinder Singh Brar, PPS, Deputy Commissioner of Police, Investigation, (Add. Charge Joint Commissioner of Police, Headquarter, Ludhiana while exercising the powers of Executive Magistrate under section 144 of Cr.PC conferred vide notification dated 05.03.2010, issued under the Punjab Police Act, 2007 by the Govt. of Punjab hereby direct that no songs are played glorifying the Vulgar, Alcoholic, Wine, Liquor, Drugs, Weaponry and violence in any song even in live shows.

This order shall come into operation w.e.f
and will remain in operation for two months.

This order of mine should be brought to the notice of the general public by beating of the drums, by pasting its copies on the notice boards of all the Police Stations, Municipal Corporation office, S.D.M. office, Tehsildar office and Sadar Kanungo office. This order should also be relayed on Doordarshan and Akashvani through public relation office and its copies should also be pasted on the conspicuous places in the city.
