**Respected Mann sahib,**

I would like to draw your kind attention towards the fact that on the 13th October, 2020, I along with Sh. Jagmohan Singh Kang, former Cabinet Minister, Punjab, and Sh. Yadwinder Kang (who are now in the Aam Aadmi Party) laid the foundation of a community centre at Naya Gaon, which is at a distance of 500 meters from your residence in Sec-2, Chandigarh.

It is unfortunate that the Government of Punjab has informed the Punjab & Haryana High Court that the project has been shut primarily because there is a paucity of funds.

Naya Gaon has a very dense population and hardly any civic amenities. In fact, I am strongly urge you to go and visit this particular township which as I earlier mentioned merely 500 meters from your residence.

Under these circumstances, I would request you to kindly sanction additional funds to ensure that this community centre is constructed at the earliest, so that the people of Naya Gaon are not deprived of basic civic facilities.

In addition to that I had also been pursuing with the previous Government that the sewerage treatment plant (STP) and sewage system should be laid in Naya Gaon, because a township with such dense population is bereft of these basic amenities.

I would also request you to kindly direct the Minister of Local Bodies to expedite this project at the earliest and if required take the proposal to the cabinet and get the required funds sanctioned and allotted.

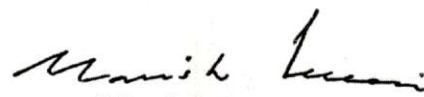
